## The Rules of the 2020

## Victor Smith Law Group Central Park Art Festival

- 1. Artists must exhibit and be present during the complete show, from 10:00 a.m. 5:00 p.m. Saturday, March 21, and from 10:00 a.m. 4:00 p.m. Sunday, March 22, 2020. Failure to follow this rule makes the artists ineligible for prizes and admission to future shows.
- 2. All work must be original, created since 2017 and signed by the artist. Artists shall exhibit only works typified by submitted email. No CD's or Photos.

Only the works of the accepted artists may be sold or displayed at the Festival.

- All reproductions must be signed and numbered.
- \* All reproductions whether framed or unframed must be clearly & individually labeled "REPRODUCTION" or "LIMITED EDITION REPRODUCTION". This notice must appear on the front of each item displayed.
- \* All framed or unframed reproductions may be displayed in a browse bin.
- \* Digital Art must be original artwork that is created on a computer, and must be signed. Original limited edition prints of digital art will be permitted, and must be signed and numbered as part of an edition. \* Photographs must be from the artist's original negative and must be signed.
- \* Ceramic works must be handmade by the artist. If multiple pieces of the same design are displayed, each must be signed.
- \* Not eligible to be exhibited: Crocheting, knitting, picture frames, velvet paintings, manufactured or kit jewelry, ceramics cast from commercial molds, art supplies, commercial displays, decoupage, candles, shell craft, bonsai, stuffed animals, hats, leather purses or wearing apparel, except one-of-a-kind items made by the artist's hand.
- \* No artist shall be allowed to sell **non-original** items at the Art Festival. For example: prints, posters, greeting cards, postcards, calendars, T-shirts and so forth.
- 3. All entries will be juried. All entrants are required to email photos of their artwork/display. Submissions must represent the basic quality and nature of the work to be exhibited. Improper or excessive photos will result in immediate rejection. The decision of the screening committee is final. Deadline for entry is January 31, 2020. All entrants will be notified of their acceptance or rejection via email on or about February 8, 2019.

A single page printout entries should be mailed with the application and your 2 separate checks.

- 4. Artist must be present. No stand-in exhibitors, dealers, agents, wholesalers. The Committee reserves the right to ask any exhibitor for identification. There will be one artist to exhibit in a space. All work must be attributed solely to the displaying artist. All works must be for sale or available for commission. No commercial displays.
- 5. When the Jury date has passed, the commitment to show will be official.

## No refunds will be made due to cancellation by the Artist after Feb 1st.

- 6. Displays will be viewed by the Viewing Committee at intervals throughout the Festival. The Viewing Committee shall have the sole discretion to require the removal of art work which violates Festival rules. Artists violating any Festival rule must remove exhibit immediately. There will be no refunds made to the Artist.
- 7. Exhibit spaces measure approximately 10' X 11'. The Artist must stay within the allotted space. No tarps beyond your area. A booth identification card will be provided to you at check-in and must be attached to the front upper left hand corner of your display during the show. Artist must provide booth frames or support structures if desired.
- 8. Artist registration and set-up will begin Friday, March 20, from 2:00 p.m.-6:00 p.m.. OR from 7:00 a.m.-9:00 a.m. on Saturday, March 21. ALL set-ups MUST be completed by 9:00 a.m. on Saturday and ALL vehicles moved to designated parking areas. No exceptions. All exhibitors must check in at the Ridge Art Registration Tent to obtain a booth card before they set up their exhibit. Artists will receive their packet of information and instructions at that time. No set-ups after 6:00 p.m. on Friday. Everyone will be attending the reception!
- 9. Artists not set-up in their spaces by 9:00 a.m. on Saturday, March 21, will lose their spaces to alternates. In the event of an emergency, late shows must call ahead to receive their space. No shows must inform the Art Festival Committee (863) 291-5661 on or before Noon, Friday, March 16, 2018. Failure to do so will disgualify them from being accepted in any future Central Park Art Festivals. Any person closing their space prior to 4:00 p.m. on Sunday, March 22 will be disgualified from future shows and will relinguish all rights to prize money.

10. Security will be provided both days.

- 11. Collection of the 7 % Florida Sales Tax on all sales is the responsibility of each exhibitor.
- 12. **NO PETS!** Artists will NOT be permitted to bring pets onto the Festival site.

The viewing committee shall have sole discretion to require the removal of work which violates any of the festival rules. Violations will result in the artist being asked to remove his/her exhibit from the festival and will be considered ineligible for future festivals.
